

Repsol Sport Centre “ThePUSH Challenge” Contest Rules and Regulations

How to Enter:

1. Must be a registrant of ThePUSH program. No additional purchase necessary in order to participate in the “ThePUSH Challenge” Contest.
2. “ThePUSH Challenge” Contest starts at 6:00 a.m. Mountain Standard Time (“MST”) on **January 22nd, 2018** and closes after all testing has been completed, by all participants During **the week of April 9th – 15th, 2018** (the “Contest Period”).
3. “ThePUSH Challenge” Contest Rules and Regulations and more about entering the contest can be found at www.repsolsportcentre.com.
4. Participants are required to participate in before & after fitness tests also known as Pre-Appraisal Week (January 22 – 28, 2018) and Post Appraisal Week (April 9 – 15, 2018). These tests will measure; **endurance, agility, push/pull, core, lower body strength, upper body strength and body composition**. Participating in ThePUSH Challenge will be considered entries.
5. By signing up for ThePUSH Challenge and completing the before and after tests participants agree to be bound by these official rules and regulations and all decisions of the Contest Sponsors.

Who Can Enter:

6. The Contest is **open to all residents of Canada** (except employees of the Contest Sponsors, and advertising and promotional agencies, and all family members of such persons and persons with whom these employees are domiciled). The Contest is subject to all federal, provincial and municipal laws and is void where prohibited. **Note:** Contestants must be at least 16 years of age at time of entry to be eligible for prizing.

Prizing:

7. There will be a grand prize awarded to one (1) male Winner and one (1) female Winner with the most measurable results. Each prize will consist of One (1) Annual Adult Membership (\$769), one (1) Annual executive locker room membership (\$419), six (6) one-hour sessions with a Personal Trainer (\$456) and One (1) Fitness Gift Prize Pack (\$250). Total estimated value: \$1,894.
8. Secondary prizing will be awarded to the male and female winners of the “80 Second Airdyne Challenge” and “3 Min Row Challenge.” The secondary prizes will consist of one (1) hour massage certificate from Lifemark in Repsol Sport Centre (\$80) as well as a one

(1) Repsol Sport Centre Swag Bag (\$200). Total estimated value: \$280.

9. All prizes must be accepted as awarded, may not be sold, exchanged, transferred or refunded and are not convertible to cash. The Contest Sponsors reserve their right to substitute a prize or prize component with one of equal or greater value.

Contest Draws:

10. One (1) male entrant and one (1) female entrant will be selected (**the “Prize Selected Entrants”**) based on the most measureable results from the two testing periods, from all eligible participants during the Contest Period. In the event of a tie there will be a random draw to determine a winner from all the eligible entries
11. The Selected Entrants will be contacted via email or phone call and given a prize notification (“Prize Notification”).
12. If the Selected Entrants do not respond to the Prize Notification within five (5) business days thereof, or does not comply with these official rules and regulations, the prize may be forfeited.
13. Return of any Prize Notification as undeliverable may result in disqualification.
14. The odds of being a winner are dependent on the number of participants in the challenge.

How to Win:

15. To be declared a winner and recipient of a prize (a “Winner”), the Selected Entrants must first, sign a statement confirming compliance with the official rules and regulations and acceptance of the prize as awarded, by entering the “ThePUSH Challenge” Contest, the Winner authorizes the Contest Sponsors to broadcast, publish and disseminate his/her name, photograph, likeness, sobriquet and voice, in connection with any further publicity carried out in connection with the “ThePUSH Challenge” Contest, at no additional compensation to the Winner beyond the awarding of the prize.
16. The Selected Entrant may also be required to submit valid proof of identity. If the Selected Entrant is unable to provide valid proof of identity he or she may, at the sole discretion of the Contest Sponsors, be disqualified.
17. To be declared a Winner and recipient of a secondary prize the “ThePUSH Challenge” participant must be the winning male and female within the “80 Second Airdyne Challenge” or “3 Min Row Challenge.” A winner in the “80 Second Airdyne Challenge” will consist of the male and female “ThePUSH Challenge”

members that get to 80 calories within the least amount of time. The "80 Second Airdyne Challenge" must be completed within the Feb 5 – 11, 2018 and must be supervised by Fitness Centre Staff. A winner in the "3 Min Row Challenge" will consist of the male and female "ThePUSH Challenge" members that registers the furthest distance on the rowing machine in the span of 3 minutes. The "3 Min Row Challenge" must be completed within the March 19 – 25, 2018 and must be supervised by Fitness Centre Staff.

Disclaimer and Liability Exclusion:

18. The Contest Sponsors reserve their right to cancel, terminate, modify, amend or extend the "ThePUSH Challenge" Contest or modify the official rules and regulations at any time without notice and shall have no liability to anyone, including entrants, for the cancellation or termination of the "ThePUSH Challenge" Contest.

19. The Contest Sponsors shall take all reasonable steps to attempt to deliver the prize to the Winner within 30 days of the satisfaction of the requirements by the Winner. Should the Contest Sponsors be unable to deliver the prize to the Winner within 30 days due to factors outside of the control or power of the Contest Sponsors, the Contest Sponsors shall have no liability in contract or tort to any person, including the Winners, for such delayed delivery.

By entering the "ThePUSH Challenge" Contest each entrant agrees that the Contest Sponsors shall not be liable for losses or injuries of any kind resulting from acceptance or possession or use of any prize awarded and entrants agree to release, discharge and hold harmless the Contest Sponsors, their respective parents, subsidiaries, successors, assigns, affiliates, licensors, agents, employees, representatives, officers, directors or shareholders, for all claims or damages arising out they will take no action against the Contest Sponsors, their respective parents, subsidiaries, successors, assigns, agents, affiliates, employees, representatives, officers, directors or shareholders for any loss or damage resulting from the Winners' participation in the "ThePUSH Challenge" Contest or acceptance, possession or use of any prize.
